IMSBC Kod Değişimleri (05-19)

MSC 462(101) ile kabul edilen kararlar IMSBC Kod İlave 1'e aşağıdaki listelenen yükler eklenmiş ve madde 1.3.3'teki yük özellikleri tablosu ikincil tehlike ve MHB (material hazardous in bulk) özelliklerini belirtmek için değiştirilerek her bir yükün özelliklerine değişim yansıtılmıştır.

Ayrıca, Seed Cake (non-hazardous) İlave 1'deki yüklerden silinmiş ve Boksit için TML (taşınabilir nem limiti) test prosedürü tanımlanmıştır. Gönüllü uygulaması başlamış olan IMSBC Kod (05-19) versiyonunun zorunlu uygulama tarihi ise 01.01.2021'dir.

Amendments of IMSBC Code (05-19)

Cargoes listed below were added to IMSBC Code appendix 1 and each individual cargoes' Characteristics table was amended to reflect amendments in item 1.3.3 to specified subsidiary hazard(s) and MHB (material hazardous in bulk).

Materials	Group
Bauxite fines	A
Brucite	C
Calcium fluoride, Calcium sulphate, Calcium carbonate mixture	A
Chlorite	C
Ferronickel slag (granulated)	C
Flue dust, containing lead and zinc	A and B
Matte containing copper and lead	B
Metal sulphide concentrates, self-heating UN 3190	A and B
Seed cakes and other residues of processed oily vegetables	B
Seed cakes and other residues of processed oily vegetables	C
Zinc oxide enriched flue dust	A and B

Moreover Seed Cake (non-hazardous) was deleted from cargoes in Appendix 1 and TML (transportable moisture limit) testing procedure was defined for Bauxite. IMSBC Code version (05-19), which voluntary implementation has already been started, mandatory implementation date is on 01.01.2021.

Ship owners or operators should apply to Türk Loydu to add new cargoes on the certificate.
