MANAGEMENT SYSTEMS CERTIFICATION RULES FOR USE OF THE CERTIFICATION MARK AND CERTIFICATE

The TÜRK LOYDU certification mark and certificate may be used in accordance with the following provisions:

- Türk Loydu certification mark is composed of TÜRK LOYDU Management Systems (QMS, EMS, OHSAS, FSMS, CCMS) mark and accreditation mark of accreditation body and may be used by the companies whose Management Systems which have been audited, deemed successful, registered and for which a management system certificate has been issued by TÜRK LOYDU.
- 2) The original colours and dimensions of TÜRK LOYDU management systems (QMS, EMS, OHSAS, FSMS, CCMS) marks are given in the attachments.
- 3) TÜRK LOYDU certification mark may be used, for commercial purpose, only for the activities certified on stationary materials, advertisement materials, stationary with letterhead and computer softwares concerning certificates in accordance with the following terms:
 - The certification mark may be used in one single colour besides its original colour.
 - The use of the certification mark must not be misleading and it must not be confused with the conformity mark of the products.
 - The certification mark must not be used, being placed on the products, computer softwares or product packages, in a way to look as if it is a product approval mark.
 - Certification mark must not be used more than one on a material,
 - Accreditation mark and number must not be used on vehicles, buildings and flags (This item is applicable only for TURKAK accreditation),
 - Accreditation mark must not be used on business cards and cards.
 - Coordination with TÜRK LOYDU must be provided when the TÜRK LOYDU certification mark is being prepared to be printed.
 - The shape of the certification mark must not be modified by no means.
 - Accreditation mark must not be used separate from TÜRK LOYDU management systems mark.
- 4) TÜRK LOYDU certification mark could not be used on product. The statement "This Product was manufactured in a plant whose Quality Management System is certified by Türk Loydu as being in conformity with the standard" could be used on packaging of the product. Product packaging is considered as that which can be removed without the product disintegrating or being damaged. Accompanying information is considered as separately available or easily detachable. Type labels or identification plates are considered as part of the product.
- 5) TÜRK LOYDU certificate describes the certification scope for the company for which the certificate is issued and also describes the details of the scope and type of certificate, names and places of sections / department / areas concerning the scope.
- 6) Certificates may be copied as smaller or bigger than the original size provided that not changing the proportionality of the original size, keeping the certificate mark size not less than 20 mm and readable.
- 7) TÜRKAK Accreditation mark's width shouldn't be bigger than 30 mm if it's used on a consumable materials not later than A4 size.
- 8) TÜRK LOYDU certificate and certification mark may only be used for activities related to the certificate scope. It must not be used for sections / departments, joint ventures and institutions or participations which are not stated in the certificate.
- 9) TÜRK LOYDU certification mark and number must not be used on the test, calibration or inspection reports and certificates. of certified companies even laboratory activities are included in scope of certificate. There shouldn't be any reference to accreditation on such reports / certificates.
- **10)** TÜRK LOYDU certification mark must never be used in such a way as could give the impression that TÜRK LOYDU and accreditation body accept any responsibility for the content of the document or for the activity concerned.

- 11) In case that TÜRK LOYDU certificate and certification mark is used in a misleading and inappropriate manner, the user shall immediately prevent the misuse, take necessary measures to settle the problem and pay indemnity.
- 12) In case that TÜRK LOYDU certificate and certification mark is used in a misleading and inappropriate manner, TÜRK LOYDU has the right to prohibit immediately the usage of TÜRK LOYDU certificate and certification mark and start legal proceedings. TÜRK LOYDU informs the accreditation body immediately.
- 13) Two original certificates and one original set of TÜRK LOYDU certification mark (in electronic media) and accreditation mark (as electronic media) be sent to the company approved by TÜRK LOYDU to execute management system certification. The place and position of the TÜRK LOYDU management systems marks and accreditation mark shall not be changed in case used together.
- **14)** The right of usage of TÜRK LOYDU certification mark ends immediately in case that the validity time is up, suspended up or withdrawn.
- **15**) TÜRK LOYDU certificate is issued on behalf of juristic persons. The certificate and its mark may not be transferred to third parties.
- 16) The IAF MLA Mark and TBDS Datamatrix must not be used by the customer.

- 17) The certified client shall:
 - conform to the requirements of the certification body when making reference to its certification status in communication media such as the internet, brochures or advertising, or other documents,
 - not make or permit any misleading statement regarding its certification,
 - not use or permit the use of a certification document or any part thereof in a misleading manner,
 - upon withdrawal of its certification, discontinues its use of all advertising matter that contains a reference to certification, as directed by the certification body,
 - amend all advertising matter when the scope of certification has been reduced,
 - not allow reference to its management system certification to be used in such a way as to imply that the certification body certifies a product (including service) or process,
 - not imply that the certification applies to activities and sites that are outside the scope of certification,
 - not use its certification in such a manner that would bring the certification body and/or certification system into disrepute and lose public trust.
